- 3. (a) Sri.V.K. Expressed fullest satisfaction and Thanked the E.I.R.C office bearers and the Former presidents from the Eeastern region for the Arrangements made, for the travel and stay of the outstation Members. It was decided to place on record the appreciation of one and all for this excellent arrangements and convey the same to the Chairman of EIRCand others, on behalf of all the members.
- 4. Sri.V.K.Requested Sri.Shyam Banerjee the seniormost memberPresent, , to take the Chair and conduct the proceedings. This was Endorsed by all.
  - Sri Shyamal Banerjee took the chair and ,after expressing his thanks for this gesture, Proceeded with the other items listed in the agenda for a discussion.

- 5. Sri.G.N. Venkataraman President Expressed his happiness in attending the meeting and assured the members, for the whole hearted support, of himself and the council, for such meetings of the Former presidents. - 6. EXPERT GROUP REPORT Sri.Kunal Banerjee narrated the Status of implementation of the EG report. There was a discussion on several issues which have to be taken care of ,by the Institute, which were raised by members , as detailed below
  - a. Industry Support- Sri.B.D.Bose
  - b. IFRS implication on Historical cost VS Present value concept-Sri.Shyamal Baneriee.
  - c. Training required For members, to Handle modified approach in the new Regime-Sri. Amitava Bhatta Charya and Sri. Hariji ban Banerjee.
  - d. Constitution of Technical Advisory Cell to guide members and Industry-Sri.D.V.Joshi
  - e. Educate the members on the New concepts Envisaged by the EG report Sri.AmalKumar Dass
  - f. Quality assurance to sustain growing demand of Practicing members as any fall in standards may result in Govt. rethinking on entrusting work to CMA's-Sri.V.K.
- 7. COST ACCOUNTING STANDARDS Sri.ChandraWadhwa Explained the status of the CAS developed so far, and the implications of the same, in cost statements it was felt The CAS should conform\Allign to IFRS requirements to enable their practical application which is being addressed by the CAS Board as a ongoing exercise after Certain basic issues, Like Indian Accounting systems and disclosures, are being seriously addressed for its alignment with IFRS, by MCA.

8. QRB MANUAL - Sri. Dhananjay V.Joshi Explained the objective, Application and contents of the QRB Manual.

Concerns were expressed, by Sri.K.L.Jaisingh on the Mechanics, Modus Operandi, of the Quality review system, as it may lead to unhealthy practices, and conflict of interests Amongst Members. . The Concerns and replies of Sri.D.V.J and were noted.

## 9. INFORMATION ON IMPORTANT EVENTS -

The members expressed that ICWAI generally should send invitations and keep former Presidents informed on important events of the Institute.Sri.V.K. narrated an Incident wherein even ICWAI office Bearers where in the Dark on a Visit by Hon'ble Minister and Secretary MCA to a chapter in the Eastern Region.

# 10. CIRCULATE ICWAI PUBLICATIONS TO FORMER PRESIDENTS -

It was Emphasised that this should be Meticulously followed as there was already a decision by the council ,that all important publications should, as a routine, be circulated to all former presidents. He explained that with Limited Liability Act being passed in the current session of Parliament a greater scope and opening Exists for the Cost Accounting professionals to render a wider range of services by forming partnership with CA's,CS,Architects.and Valuers.
